	 Every village in a SC has to be targeted equally(on rotation basis) while assigning event in case of SC HWCs. 		
	 Every SC under a PHC HWCs will be equally targeted while assigning event in case of PHC HWCS. 		
	 No of activities planned must not be less than 24 per annum & total Budget shall not be more than the allocation in any circumstances. (i.e. Rs.25000/- per SC HWCs & Rs.50,000 per PHC HWCs per annum). 		
	There is separate budget head provisioned for conducting Yoga sessions (so cost for conducting Yoga sessions shall not be part of Rs25000/- meant for SC HWC & Rs.50000/- for PHC HWCs)

The SIHFW at State level will spearhead the activity for smooth implementation at field level.
