The candidates will be elected by Members of the G.B. by casting of vote through ballot or online voting through official portal of the association.
- iii) The office bearers so elected will have tenure of 3 years (Three Years) from the date of declaration of result.
- iv) The office bearers for State and District Unit shall be from all the Streams (AYUSH) out of which two should be female.
- v) The Executive Members in a District unit will be selected / elected by the General Body of the concerned District as per the process decided by the State Body.
- vi) The tenure of the District Office bearers will be the same as the tenure of the State Office bearers. However, the G.B. may decide and extension for 1-3 months for some important execution and in such a case the office for the subsequent tenure will be for the rest of the period exists.
- vii) The Election of the District Unit shall be done for the post of One President, One Vice-President, One Secretary, One Asst. Secretary and One Treasurer.

viii) The Election for the State Office Bearer shall be done for the post of One President, Three Vice-president, One General Secretary, Six Joint Secretary, One Treasurer and Five Zonal Executive Members. One Vice-President and One Joint Secretary will be from the females and three Joint Secretaries for IT & Media will be selected by the 14 Elected State Body Members. Zonal Executive Members will be Elected by the concerned Zonal Districts. At present all 30 districts are divided in Five Zones i.e. East, West, North, South & Central Zone.

4. MEMBERSHIP

Each AYUSH Doctor, working under Mission Directorate, NHM, Deptt. - iv) The Membership shall automatically cease in the event of non-payment of prescribed fees or by resignation from the service or expulsion and non-adherence to the constitution, rules and decisions of the association and in that event all benefits accruing him / her shall automatically forfeited.
- v) In the event of transfer of the member from one district to another, he / she shall be considered to be a member of the association in the district to which he / she is transferred.
- vi) The District Executive Body shall send a list of its members to the State Executive Body, soon after District Executive Body Meet and all addition and alterations made to the list earlier submitted shall be reported to the State Executive Body.
- vii) No member of the association shall submit to the authorities any representations affecting the interest in general without approval of the State Executive Body to be previously obtained through District Unit concerned or of the District Unit as the case may be.
- viii) The District Unit shall adopt the model rules or business framed by the SEB with such alternations, if any, as may be required by the local conditions subject to the previous approval of the District Executive Body.

CESSATION OF MEMBERSHIP

- i) The membership will be ceased after nonpayment of monthly subscription of amount Rs. 50/- continuous for three months.
- ii) The membership will be ceased in case of absence from EB Meeting of both District & State for continuous three times.
- iii) In case of breakage of loyalty to the aims and objectives of the association, the membership will be closed.
- iv) In case she / he gives statement inside or outside of society, the membership will be cancelled.

REVIVAL OF MEMBERSHIP

- i) The ceased membership may be renewed and revived by payment of arrear fees, subscription and/or special subscription by a decision of State Executive Body of association.
 - Ceased Membership by disciplinary action, however may be revived by grant of pardon/amnesty of the association if so sought for by the delinquent member concerned.

5. FUNDS & ITS MANAGEMENT:

The state unit also shall open the Bank A/C operated by joint signature of General Secretary and Treasurer of the State.

The district unit shall open the Bank A/C operated by joint signature of Secretary and Treasurer of the concerned district.

- i) Fifty percent of the subscription realized by the District Unit shall be sent to the State Unit for the purpose of carrying business of the association.
- ii) All expenditure shall be incurred in accordance with the budget approved in the EB Meeting.
- The General Secretary of the State Unit can retain cash up to Rs. 10,000/- (Ten Thousand) in hand to meet day to day expenditure.
- iv) The Treasurer of the State and District can retain cash up to Rs. 5000/- (Five Thousand) in hand to meet emergency expenditure.
- v) All Bills/Vouchers/Invoices/quotations and Accounts details shall be signed by General Secretary and maintained by the Treasurer and keep all the records of Financial Transactions. At District label the Secretary & Treasurer of the concerned district will keep all financial transaction records.
- vi) The State Executive Body may desire to audit the accounts for a session by appointing a committee or an expert by fixing its consultation fees.
- vii) Sources of collection of funds for expenditure and development works of association and other public benefit projects are:
 - a) Admission fees from the members.
 - b) Monthly subscription from the members
 - c) Donation from Different Sources
 - d) Govt. Aid

6. ACCOUNTS OF THE SOCIETY

The association shall open any type of Bank Account or Accounts in the name of the Association at the State Label and District Label in any Nationalized / Scheduled Bank/ Other Financial institutes like State Bank of India as they shall decide time to time. The Bank A/C (s) will be operated under joint signature of General Secretary and Treasurer at State Label. At District Label Secretary and Treasurer of the concerned district will be the joint signatory.

OPERATION OF ACCOUNTS

Payment &Withdrawal of funds will be made with the signature of the Joint Signatories with proper approval of the Executive Body at State & District Label.

RECORDS OF THE ASSOCIATION
